WARRANTY – A.L.P. Lighting Components Dur-Illume 2200™ Lighting Plastic

WARRANTY:

Pursuant to the terms and limitations set forth herein, A.L.P. Lighting, Inc. warrants that, for a period of five (5) years from the date of purchase (“Warranty Period”) that lighting diffuser product extruded and formed utilizing Dur-Illume 2200™ manufactured by A.L.P. will not break from impact or undergo a change in Yellowness Index greater than five (5) units as a result of application use as a lighting diffuser material in a linear fluorescent lamp luminaire, when tested by A.L.P. in accordance with the procedures specified in ASTM-E-313.

CONDITIONS FOR CLAIMS:

In order to make a claim under this Warranty, Customer must return the used lighting diffuser material, applicable sales receipts and this Warranty to the A.L.P. All such claims must be received by A.L.P. within the Warranty Period, and within thirty (30) days of Customer’s knowledge of a potential claim under this Limited Warranty.

EXCLUSIONS AND LIMITATIONS:

This Warranty does not cover any damage or loss caused by: (I) improper installation or maintenance (including cleaning), harmful chemical action, (II) the use in any non-UL approved linear fluorescent lamp luminaire or any device (including lamps) that A.L.P. has published as non-suitable for use with Dur-Illume 2200™, (III) outdoor use, (IV) cutting, tearing, punctures or creases caused by rough handling or transportation.

A.L.P. will not be liable for any special, consequential or incidental damages which may result from the use or application of the warranted product. A.L.P.’s sole liability for a legitimate claim under this Warranty will be the replacement of the warranted product or, at the option of A.L.P. the refund of the original purchase price thereof. In no event will A.L.P. be liable for an amount greater than the purchase price for the warranted product in question.

EXCEPT FOR WARRANTY OF TITLE, THIS IS THE SOLE WARRANTY APPLICABLE TO LIGHTING DIFFUSERS MANUFACTURED BY A.L.P. UTILIZING DUR-ILLUME 2200™, ALL OTHER WARRANTIES (WRITTEN OR ORAL, EXPRESSED OR IMPLIED) ARE EXCLUDED, INCLUDING FITNESS FOR PURPOSE AND MERCHANTABILITY. THE REMEDIES PROVIDED HEREIN ARE PURCHASER’S SOLE AND EXCLUSIVE REMEDIES WITH RESPECT TO THIS LIMITED WARRANTY.
